This 2-part session focuses on two topics that impact the lives of women at local and regional level. Each part will last one hour.</p> <p>The <u>equal representation and influence</u> of women and men in political life, at all levels of governance, is a prerequisite for a democratic society. It is critical to the progress of gender equality and for effective decision-taking and policy-making. The speakers in Part I of this session will address women's political participation and empowerment and share their specific experiences as elected officials and experts.</p> <p>In Part II of this session, issues linked to public space and safety, both online and on the ground, will be explored. It is clear that urgent action must be taken at all levels of governance to prevent violence against women and girls, assist victims and survivors, hold perpetrators accountable, and raise awareness about all forms of violence against women, with a view to changing attitudes and behaviours. But the financial crisis has pushed unemployment, poverty and social exclusion levels to record highs. Many cities have also been subject to budgetary cuts, pressuring them to respond to escalating needs with fewer resources.</p> <p>City governments need to be involved in the development and implementation of national and EU social policies. The local alliances presented during this session demonstrate that, as the level of governance closest to people, city governments are exposed to social challenges and have substantial experience in shaping effective responses by creating strong partnership with local stakeholders. Equality between women and men, girls and boys, is a fundamental right and a core value of the European Union. It is a prerequisite and constitutive condition for sustainable development. Gender equality and the empowerment of women and girls is one of the 2030 Sustainable Development Goals set by the United Nations and promoting gender equality beyond its borders within the framework of its foreign policy is also a high priority for the European Union. Equality between women and men is a major development challenge as it is both a goal in itself and a development tool.

This workshop will present the key findings and tools of the study *"Promoting gender equality: towards a gender-based approach in decentralised cooperation projects"* which was carried out by the French section of the Council of European Municipalities and Regions (AFCCRE) in the framework of PLATFORMA. Eleanor Roosevelt explained that universal human rights begin in "small places, close to home – so close and so small that they cannot be seen on any maps of the world. Unless these rights have meaning there, they have little meaning anywhere". As employers and service providers, local and regional governments are the ones in charge of making of these rights a reality for each one of us, young, old, woman, man, heterosexual, lesbian, gay, bisexual, trans- and inter-gender, catholic, atheist, or Muslim, Black or White, whoever we are and whatever our abilities may be.

However, significant differences persist across the region, both between and within Member States. For example, there is a gap in life expectancy of about 16 years between some countries and the differences are even greater when gender and other inequalities are taken into account. Income and wealth disparities lead to differences in the “social determinants of health” as well as the direct health care that individuals receive.</p> <p>Local government, as a provider of education, housing, and other social and care services, is well-equipped to put in place preventative measures and to tackle the consequences of health inequalities.</p> <p>This session will explore the strategies local governments are putting in place to improve the health of citizens, in particular those who are at heightened risk of exclusion.
